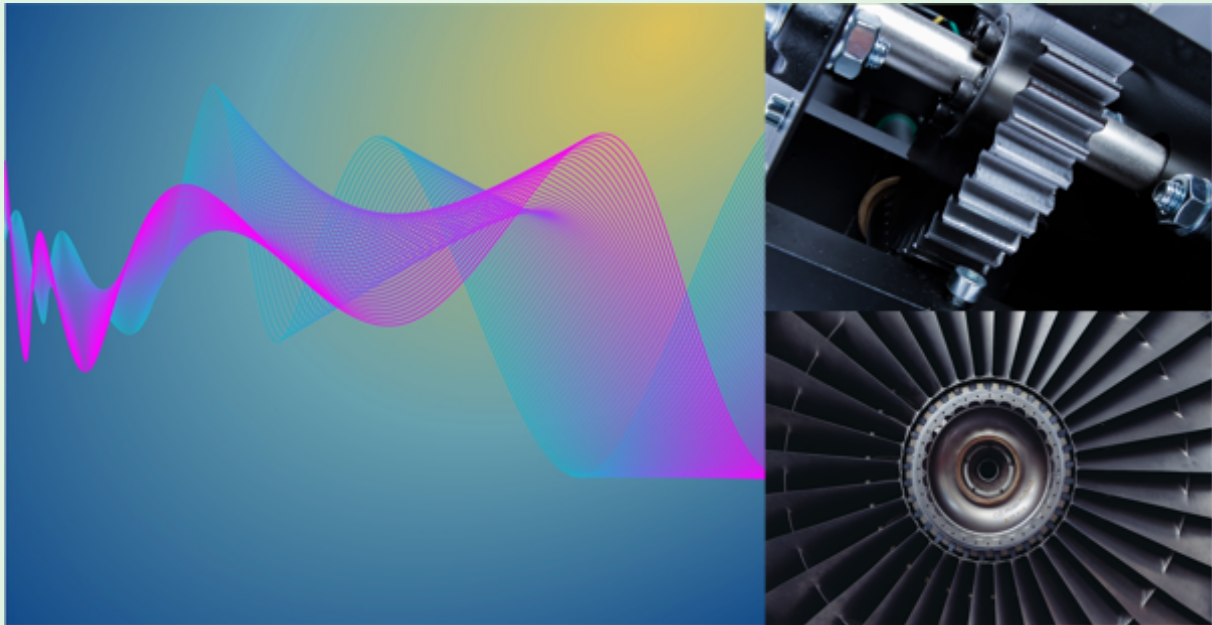

Summary of the Course

This course builds upon the acquired knowledge of an introductory course in vibrations (such as MMAN2300) where you will have studied oscillatory systems under a number of simplifying assumptions – sinusoidal forcing, constant coefficients, simple boundary conditions, etc. In this course, you will examine more complex systems and excitations. As such, you will be exposed to new techniques for seeing, measuring, thinking about, analysing and designing oscillatory systems. These analytical and computational tools will be applied to the challenging and critical application of machine condition monitoring. Vibration-based condition monitoring is a large and expanding field of engineering research and application, which allows massive safety improvements and economic advantages in almost every industry.

The following assumed knowledge is expected for students undertaking this course: MATH2019 and MMAN2300.

Areas of study include: free and forced responses of single degree-of-freedom spring-mass-damper systems; harmonic analysis; linear vibrations of multi-degree-of-freedom systems, normal modes; analysis of continuous systems, longitudinal/torsional vibration of bars and rods, bending vibration of beams; vibration measuring instruments; experimental vibration analysis; typical sources of vibration in machines; modal analysis; vibration testing; typical machine and machine component faults and corresponding vibration signatures; diagnostic procedures and related signal processing techniques.

Teaching Strategies

There are two teaching activities in a typical week which we refer to as the Lecture and Problem Solving Class (PSC). Lectures will be delivered online using Microsoft Teams. The lectures in this course will cover core concepts and background theory in vibration analysis, measurement and machine condition monitoring. The lecture material will be available to students electronically before each class via Moodle.

The PSCs are designed to provide you with feedback and discussion on worked questions provided on the course Moodle page. Students are required to work through the exercises during the PSC and during their own personal study time.

Due to pandemic restrictions, face-to-face classes have been cancelled until further notice. As a result, all students are to attend PSCs in online mode. You will be notified if the situation changes.

The teaching activities in this course are organised on the following principles:

1. **Learning:** Student learning is the first priority - teaching and assessment are secondary concerns. Learning here is defined as gaining new ways of understanding the field of vibration analysis; not as simply memorising information. We are trying to transform you into engineers and critical thinkers in the discipline.
2. **Authenticity:** We will have as much authenticity of engineering practice as is possible within the constraints of the course and where it does not restrain your learning.
3. **High standards:** We will have high standards for achievement in the course, and everyone (including staff) will be accountable for putting in the effort to get you to the standard.
4. **Openness:** As much as possible, this course will be conducted in the open where all participants can be aware of it and can comment upon it.
5. **Process:** The focus of the course will be on processes, not outcomes. The right outcomes will be a by-product of following the correct processes.

Course Evaluation and Development

Feedback on the course is gathered periodically using various means, including the UNSW myExperience process, informal discussion in the final class for the course, and the School's Student/Staff meetings. Your feedback is taken seriously, and continual improvements are made to the course based, in part, on such feedback.

In this course, recent improvements resulting from student feedback include providing more worked examples with full MATLAB code in the PSCs and on the course Moodle page.

Submission of Assessment Tasks

Assessment submission and marking criteria

Should the course have any non-electronic assessment submission, these should have a standard School cover sheet.

All submissions are expected to be neat and clearly set out. Your results are the pinnacle of all your hard work and should be treated with due respect. Presenting results clearly gives the marker the best chance of understanding your method; even if the numerical results are incorrect.

Marking guidelines for assignment submissions will be provided at the same time as assignment details to assist with meeting assessable requirements. Submissions will be marked according to the marking guidelines provided.

Late policy

Work submitted late without an approved extension by the course coordinator or delegated authority is subject to a late penalty of 20 percent (20%) of the maximum mark possible for that assessment item, per calendar day, for a minimum of zero marks.

The late penalty is applied per calendar day (or part thereof), including weekends and public holidays, that the assessment is overdue.

Work submitted after the 'deadline for absolute fail' is not accepted and a mark of zero will be awarded for that assessment item. For example:

- Your course has an assessment task worth a total of **30 marks (Max Possible Mark)**
- You submit the assessment **2 days after the due date**
- The assessment is marked as usual and achieves a score of **20 marks (Awarded Mark)**
- The late policy is applied using **Late Mark = Awarded Mark - (Days*Penalty per Day)*Max Possible Mark**. Your adjusted final score is **8 marks** ($20 - ((2*0.2)*30)$).

For some assessment items, a late penalty may not be appropriate. These are clearly indicated in the course outline, and such assessments receive a mark of zero if not completed by the specified date. Examples include:

1. Weekly online tests or laboratory work worth a small proportion of the subject mark, or
2. Online quizzes where answers are released to students on completion, or
3. Professional assessment tasks, where the intention is to create an authentic assessment that has an absolute submission date, or
4. Pass/Fail assessment tasks.

You must be available for all quizzes, tests and examinations. For courses that have final examinations, these are held during the University examination periods: February for Summer Term, May for T1, August for T2, and November/December for T3.

Special Consideration

If you have experienced an illness or misadventure beyond your control that will interfere with your assessment performance, you are eligible to apply for Special Consideration prior to submitting an assessment or sitting an exam.

Special Consideration Outcomes

Assessments have default Special Consideration outcomes. The default outcome for the assessment will be advised when you apply for Special Consideration. Below is the list of possible outcomes:

Outcome	Explanation	Example
Time extension	Student provided more time to submit the assessment	e.g. 1 more week of time granted to submit a report
Supplementary assessment	Student provided an alternate assessment at a later date/time	e.g. a supplementary exam is scheduled during the supplementary exam period of the term
Substitute item	The mark for the missed assessment is substituted with the mark of another assessment	e.g. mark for Quiz 1 applied also applied as mark for Quiz 2, meaning if a student achieved a mark of 20/30 for Quiz 1 and was granted Special Consideration for Quiz 2, a mark of 20/30 would be applied for Quiz 2, etc
Exemption	All course marks are recalculated excluding this assessment and its weighting	e.g. The course has an assessment structure of: - Assignments 30%, - Lab report 30%, - Final Exam 40%. If the Lab report is missed and student is granted Special Consideration, then the assessment structure may be reweighted as follows: - Assignments 50% - Final Exam 50% as though the Lab report did not exist
Non-standard	Course Coordinator is contacted for the outcome when special consideration is granted as the outcome differs on a case-by-case basis	e.g. typical for group assessments where time extension supplementary assessment could be granted to the group member, time extension could be granted to the whole group, etc. Clarify with your Course Convenor for

If plagiarism is found in your work when you are in first year, your lecturer will offer you assistance to improve your academic skills. However more serious instances in first year, such as stealing another student's work or paying someone to do your work, may be investigated under the Student Misconduct Procedures.

Repeated plagiarism (even in first year), plagiarism after first year, or serious instances, may also be investigated under the Student Misconduct Procedures. The penalties under the procedures can include a reduction in marks, failing a course or for the most serious matters (like plagiarism in an honours thesis) even suspension from the university. Academic Information

Credit points

Course credit is calculated in Units-Of-Credit (UOC). The normal workload expectation for one UOC is approximately 25 hours per term. This includes class contact hours, private study, other learning activities, preparation and time spent on all assessable work.

Most coursework courses at UNSW are 6 UOC and involve an estimated 150 hours to complete, for both regular and intensive terms. Each course includes a prescribed number of hours per week (h/w) of scheduled face-to-face and/or online contact.
